Participation in a business mission is considered confirmed after payment. CCI France Russie offers participants a set of services provided by the business mission program.

If the company confirms its participation less than 3 weeks before the date of departure, CCI France Russie takes into account the wishes for arranging meetings, but does not guarantee compliance with all requirements.

For a full refund of participation costs, a refusal must be registered at least 14 days before the start date of the trip. In case of termination of the contract between 6 and 14 business days before the date of commencement of the trip, the cancellation fee is 50% of the cost of participation in the business mission. In case of termination of the contract within 5 working days or less before the starting date of the trip, the fee is 100% of the cost of participation.
